PREAMBLE :

The Government in G.O.(Ms).No. 77, Health and Family Welfare (PME-2) Department, dated 05.03.2019 has granted permission to the Managing Trustee, Dharan Educational Charitable Trust, Salem to start 4 years B.Sc Nursing Course at Dharan College of Nursing in S.F.No. 3/136, Pallipalayam Spinning Mills Nilavarapatti, Salem District with an annual intake of 100 students from the academic year 2019-2020.

In the reference 2nd cited, The Government in G.O.(Ms).No. 112, Health and Family Welfare (PME-2) Department, dated 20.03.2019 has amendment the following to the Government Order 1st cited above.

AMENDMENT

In G.O.(Ms).No. 77, Health and Family Welfare (PME-2) Department, dated 05.03.2019, the expression "Dharan Nursing College, Salem" shall be substituted instead of "Dharan College of Nursing, Salem" wherever it occurs.

In the reference 3rd cited, the University has granted Provisional Affiliation to Dharan Nursing College, S.F.No. 136, Pallipalayam Spinning Mills, Nilavarapatti, Salem - 636 201 for starting 1st year B.Sc(N) Degree Course with an annual intake of 100 seats from the academic year 2019-2020.

In the reference 4th cited, Indian Nursing Council, New Delhi has granted suitability to Dharan Nursing College, Salem to conduct B.Sc(N) with annual intake of 100 (one hundred) seats for the academic year 2020-2021.

In the reference 5th cited, Tamil Nadu Nurses & Midwives Council, Chennai has published the list of colleges of Nursing for B.Sc(N) course recognised for the academic year 2020-2021, wherein Dharan Nursing College, Salem has been granted recognition to conduct B.Sc (N) with an annual intake of 100 seats for the academic year 2020-2021.

As the Building of the said institution is situated in the Plan area, the Trust has submitted an Undertaking duly signed by the Managing Trustee for the academic year 2020-2021 with regards to DTCP approval procedures.

Due to Covid-19 Pandemic, the University inspection of the B.Sc(N) Degree Course with an annual intake of 100 seats could not be conducted. Based on the Resolution No.4(1) passed at the 277th Governing Council meeting held on 30.09.2020, the Trust has submitted a notarized affidavit duly signed by the Managing Trustee to abide by the appropriate rules regarding non conduct of regular inspection for the academic year 2020-2021.

ORDER:-

Based on the approval of the relevant nursing council's and Governing Council Resolution held on 30.09.2020, the Tamil Nadu Dr. M.G.R. Medical University, Chennai grants Conditional Continuance of Provisional Affiliation to Dharan Nursing College, S.F.No. 136, Pallipalayam Spinning Mills, Nilavarapatti, Salem - 636 201, to conduct 1st year and to start 2nd year B.Sc.(N) Degree course for the academic year 2020-2021, subject to the conditions that to submit the building plan approval along with the proceedings from the competent authorities.

2. The seats available in B.Sc(Nursing) Degree Course shall be filled as per the orders in force. The Management shall follow a transparent and reasonable method of admission for the management quota as per orders in force.
3. The admission procedure of the Government as per the scheme of admission enunciated by the Supreme Court of India should be followed.
4. The admission procedure as laid down in the G.O., of Health and Family Welfare Department, Chennai should be followed strictly. Any admission made over and above will not be permissible on any account.
5. The renewal of approvals from relevant Councils should be produced on expiry of their validity to consider further Continuance of Provisional Affiliation.
6. Any other condition which the University considers necessary to impose from time to time should be followed.
