This has reference to your proposal which has been submitted by your institution to start B.Sc.,(N) programme for the academic year 2019-2020. Your institution was inspected on 06.04.2019. After going through the report, comments of the inspectors, documents and compliance report submitted by the institution (vide ref.No:6), we are herewith communicating a copy of the resolution of the Council passed at its meeting held on 17.05.19 for information and necessary action.

Extract of the resolution of the Council

"The Tamil Nadu Nurses and Midwives Council having noted the clearance given by the Tamil Nadu Government for starting a College of Nursing for degree programme in Basic B.Sc., Nursing at **Dharan Nursing College**, **Salem** and having satisfied itself with the infrastructure available in the institution as pointed out in the Primary/Statutory inspection report and in exercise of the powers vested with the Council under rule 37 of the rules made under Section 11(2) (c) of the Tamil Nadu Nurses and Midwives Act (Act III) 1926 resolves to grant Provisional Recognition to the above said institution to conduct the first year Basic B.Sc., Nursing Programme for the academic year 2019-2020 only with an annual intake of not exceeding 100 students subject to the following conditions:

- 1. Do not admit underage & overage students.
- Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2019-2020 and admission must be made only once a year.
- 3. Fresh batch of admission of students is permitted for 2019-2020 only.
- 4. Every year list of candidates admitted during the year together with their age and qualification to be uploaded in the Council's Institutional Management Software (I.M.S.) for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.
- 5. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.
- 6. The institution should obtain Affiliation Order from the Tamil Nadu Dr.M.G.R.Medical University for the academic year 2019-2020 before admitting the students and should submit the copy of the same to this Council.

- 7. The Trust should obtain the building completion certificate from the competent authority and building plan approval from the Directorate of Town and Country Planning (DTCP) for the proposed Nursing College and submit to the Government before admitting the students as mentioned in the Government Order No: G.O.(MS)No:77/H&F.W (PME-2) Dept., dated 05.03.19
- 8. Failure to maintain the prescribed requirements will result in de-recognition.
- 9. Inspection will be arranged by this Council before starting II-batch of programme in 2020-2021 under Rule (38) of the rules framed under section 11 (2) (c) of the Tamil Nadu Nurses and Midwives Act III of 1926 and students should be admitted for II year afterwards only.
- 10. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, State Government/ Indian Nursing Council, New Delhi from time to time.
- 11. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
- 12. If at any time the institution will found un-suitable, the recognition will be withdrawn forthwith by Indian Nursing Council, New Delhi/Tamil Nadu Nurses and Midwives Council.
- 13. The institution should submit the Registration Certificate under "Clinical Establishment Act" from Directorate of Medical and Rural Health Services within one month.
- 14. Annual Programme fee of Rs.10,000/-must be paid by 30th June every year.
- 15. Council Prescribed Uniform for Clinical for the students should be strictly adhered.
